## 3. HAZARDS IDENTIFICATION

Irritating to skin and eyes. Toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

#### 4. FIRST AID MEASURES

#### **ENGINEERING MEASURES**
