3. HAZARDS IDENTIFICATION

Irritating to eyes. Harmful by inhalation. May cause sensitisation by skin contact. Very toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES
